



# Basic CIT-FO Certification Class

## ~Class Overview~

The Basic Crisis Intervention Class (CIT-FO) is designed to be an interactive five day, 40-hour class, which addresses basic verbal de-escalation skills, designed for sworn law enforcement officers. During the course of the week-long class participants will gain knowledge regarding crises & how people respond or behave in crisis. The concept of mental illness & its effect on the verbal interaction.

Participants are expected to actively engage in over ten hours of live scenario situations. One of our goals is to teach officers about crises & mental illness in order to improve their ability & confidence to predict & respond to abnormal behaviors. We believe that if you can predict or anticipate behavior with some degree of accuracy you can become a safer officer.

Through the class activities participants will gain an overall understanding that CIT is designed to be an added tool for the Law Enforcement Officer's tool belt. It is not designed to be a replacement for current skills or other tools. During the week we will identify key issues & history that have prompted law enforcement agencies to pursue more innovative approaches (such as officer safety, decrease in chronic callers, etc.) to crisis management such as CIT.

The class instructors will be current law enforcement officers, police psychologists, mental health providers, and retired law enforcement officers with extensive expertise and experience in verbal de-escalation and crisis management.

## Course Director: Dr. Troy Rodgers

Dr. Rodgers is a police psychologist based in Albuquerque, New Mexico. He has a master's degree and a doctorate in clinical forensic psychology. He has worked with law enforcement officers for over 20 years. At the present time, Dr. Rodgers works as a consultant to over 500 local, state, and federal law enforcement, firefighter, ambulance, dispatch and corrections agencies.

Dr. Rodgers is a highly sought after trainer in the field of psychology and criminal justice. He is routinely utilized as an expert by multiple regional media outlets. Dr. Rodgers is also certified as a Professional Lecturer and Master Instructor by the New Mexico Department of Public Safety Training Academy.
